

Privacy Policy

YOU, THE VISITOR OF THIS WEBSITE (HTTPS://PRESALE.VENTURES/) ("WEBSITE") OR THE USER OF ANY PART OF THE ACTIVITIES (AS DEFINED IN THE TERMS) ("YOU", "YOUR" AND "YOURS") PLEASE READ THE FOLLOWING PRIVACY POLICY ("POLICY") AND THE [TERMS AND CONDITIONS OF USE](#) ("TERMS") CAREFULLY BEFORE USING THIS WEBSITE. THE SERVICES PROVIDED ON THIS WEBSITE ("SERVICES") AND THE CONTENT PROVIDED WITHIN THIS WEBSITE ("CONTENT") ARE FOR PRIVATE INDIVIDUALS OVER THE LEGAL AGE OF MATURITY THAT ACCEPTED THE TERMS AND RESIDING IN A JURISDICTION WHERE THE OFFERED ACTIVITIES (AS DEFINED IN THE TERMS) AND THE WEBSITE'S SPECIFIC OPERATIONS, I.E., THE WEBSITE, SERVICES, AND CONTENT ("OPERATIONS") COMPLY WITH YOUR LOCAL LAW OR REGULATION. It is essential for us to assist our Website's visitors and users of our Operations and Activities in retaining their privacy. That is why we are following a simple guideline - Your privacy is important to us as it is important to You - and ask You to read this Policy carefully since it describes our practices regarding data collection and how we will treat it.

It is our policy not to collect any information that personally identifies You (Personally Identifiable Information ("PII")) through Your interaction with and/or Your use of any of the Operations.

However, we use third party service providers' services for the Operations and Activities which are owned and operated by third parties including, for example, business partners, sub-contractors in technical, payment and delivery services, advertising networks, analytics providers, search information providers, credit reference agencies, etc. ("Service Providers") Your PII may be collected and processed by such Service Providers. Please note that we do not have any control over such Service Providers and do not have any access to any information interactions between You and any of such Service Providers. We encourage You to read such Service Providers services' terms of use and privacy policies prior to Your interaction with the Operations and/or the Activities.

By visiting the Website and/or using any part of the Services and/or Content You understand, consent to and agree with all the provisions of this Policy, including without limitation, the gathering and use of information in accordance with this Policy.

Notice to Parents. Parents and guardians, please note that the Website, Services, and Content are not suitable for children. Therefore, we encourage You to share with Your children about the safe and responsible use of the Internet and educate them that the Website, Services, and Content are appropriate to anyone as of a certain age, where specific world-view and psychological consolidation has been established, usually when one arrives at maturity.

1. Information that You may provide.

- 1.1. We may provide to our Website's visitors intending to purchase Tokens an option to signup to our Initial Membership Offering email notifications through an online form.
- 1.2. You may provide us with Your name, email address ("Contact Details") and the number of Tokens You intend to buy and we shall use Your Contact Details for the sole purpose of providing information on the upcoming Tokens' sale, Activities, and other related issues.
- 1.3. Your Contact Details may be regarded in certain jurisdictions as PII. Therefore we shall treat such Contact Details as PII and not associate, combine or link in any way or fashion between Your Contact Details and the Data (as defined below).
- 1.4. You may request, at any time, that we shall delete Your Contact Details by sending an email to support@presale.ventures and provide the Contact Details You wish to remove from our list.

2. NO Collection, Use or Disclosure of PII.

- 2.1. Without Your consent or as required by law, we do not collect, use or disclose any PII for any purpose, except as stipulated in this Policy.
- 2.2. Apart from the Contact Details You may provide us, the Operations does not have access to any PII and/or information regarding a legal or natural person which is or can be identified, directly or indirectly, by reference to any other information, or any such information that may be used to identify the user or the owner of the device which the user interacts with the Operations ("Device").
- 2.3. We do not have any access to Your name, nickname, specific, quantifiable characteristics such as age or gender, or any other content stored in Your Device not described in this Policy.

- 2.4. Apart from the Contact Details You may provide us; Your PII may only be collected by Service Providers and only when You voluntarily agree to provide Your PII through one of their PII collection forms or direct interaction with such Service Providers' services.
 - 2.5. When You purchase or receive any service or product from Service Providers may ask You to register electronically. When You do so, such Service Providers may merge Your registration information with any none PII information You have already provided to us and/or collected by us.
 - 2.6. We shall not share Your Contact Details with any third party except through the use of certain communication services provided by the Service Providers.
 - 2.7. We may share freely with any of our affiliates, partners or any other third parties including our Service Providers any Data collected by us. This information may include statistical information collected by us or aggregated from our Service Providers.
3. **Information Collection.** We collect information related to Your use of the Operations ("Data") such as:
- 3.1. **Information we receive from other sources.** We may collect none PII about Your interaction with our Operations and Your use of any of the other websites we may operate or any of Your use of other services and content we may provide. We are also working closely with Service Providers and may receive non-PII information about You from them.
 - 3.2. **Website Activity.**
 - 3.2.1. Certain non-PII Website's activity information is automatically collected and logged by our servers for research and development purposes. Such non-PII information may include specific IP address used by You to connect Your Device to the Internet, operating system, platform, date and time of visit, time zone setting, referrals information, browser type / version / plug-in, Device type and version, Internet service provider, mobile carrier, language settings, connection type, and any other technical information.
 - 3.2.2. Certain non-PII Website activity information regarding Your visit can be collected, including URLs, through and from the Website (including date and time), Content You viewed or searched for, page response times, errors, length of visit, Website's pages interaction such as clicks, mouse-overs and any other part of Your Website's browsing activities.
 - 3.3. **Cookies.** We use cookies for the purpose of Your connections and sessions on the Website. When You use the Website, we assign to You a personal identification number then send it to Your hard drive in the form of a cookie, which is a tiny bit of code which is uniquely Yours.
4. **Service Providers.**
- 4.1. We may employ Service Providers to facilitate the Operations proper operation, to provide the Services and/or Content on our behalf, or to assist us in analyzing how our Operations are used.
 - 4.2. Although we do not have control over how the Service Providers uses the Data being collected from Your Website's use, we did our best to make sure that such Service Providers' carry the same or higher level of privacy guidelines as we do.
 - 4.3. This Policy does not incorporate such Service Providers' services, and You shall find in this Policy reference to the Service Providers own separate privacy policies that govern their operations.
 - 4.4. The Service Providers may access to some technical information about the Device such as IP address and device identifiers, as well as events completed, or actions taken within the Website including metadata in Website's communications and the value and details of purchases.
 - 4.5. The Service Providers may employ cookies or any other related technologies for a variety of purposes, including: to learn more about how the Website and/or Service Providers' services are used and similar analytical purposes, to understand how users interact with ads, to understand how to improve performance, to prevent fraud, to customize Service Providers' service.
 - 4.6. We may have access to aggregated reports about the Website's activity in general. These reports are based, in part, on Your Website's activities, but do not specifically identify You or the Device.
 - 4.7. Some Data collected by the Service Providers may be used by Service Providers' ads for personalized advertising or to utilize the Data collected to track and examine the use of the Website, to prepare reports on its activities and share them with other Service Providers' services
 - 4.8. **Google Analytics.**
 - 4.8.1. We use Google Analytics ("GA") services to monitor and collect Data on the Website's use. GA is an analytics service provided by Google Inc. and/or any other of Google's related companies and/or affiliates ("Google"). As far as we know, GA's place of Data processing is in the United States.

4.8.3. Google may provide You, through Your Device's operating system, the option of limiting tracking and targeting.

4.8.4. We cannot control Your Device nor any of its operating system's options. You may use Your Device's opt-out mechanism to cancel third party personalized advertisements.

5. **International Data Transfer.**

5.1. The Data and/or Contact Details may be transferred to, and maintained on, technological means located outside of Your state, province, country or other governmental jurisdiction where the relevant data protection laws may differ than those from Your jurisdiction.

5.2. If You choose to provide the Contact Details to us, please note that we transfer such information outside Your jurisdiction which may include outside the European Union jurisdiction, or to any other jurisdiction of our Service Providers and process it there.

5.3. Your consent to this Policy by your use of the Website represents Your agreement to such information transfer.

6. **Compliance.**

6.1. We shall disclose any information we may possess where required to do so under law or subpoena or if we believe that such action is necessary to comply with the law and the reasonable requests of law enforcement or to protect the security or integrity of our Operations and Activities.

6.2. If for some reason You believe some of this Policy principles were not kept, please notify us by email at support@presale.ventures and we will do our best to determine and correct the issue promptly.

6.3. The Website may provide content produced and handled by third parties such as advertisers and/or provide links to third party's content and/or website(s) and/or services and/or products.

7. **Policy Changes.**

7.1. We may update this Policy from time to time. However, we will not modify the Policy in such a fashion that may diminish Your rights under this Policy without receiving Your explicit consent.
